For <a href="#">out of network providers</a> \$20000 person / \$40000 family Doesn't apply to <a href="#">preventive care</a> .	You must pay all the costs up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay for covered services you use. Check your policy or <a href="#">plan</a> document to see when the <a href="#">deductible</a> starts over (usually, but not always, January 1st). Are there services covered before you meet your <a href="#">deductible</a> ?
